

FLUKE SOLUTIONS FREE TWO WEEK PRODUCT EVALUATION TRIAL TERMS & CONDITIONS

1. ELIGIBILITY

A free two week product evaluation trial of select Fluke tools (the "Promotion") is available for eligible customers in Australia between 4 March, 2015 and 30 June 2015. Void where prohibited by law. Participants must complete and return a Product Evaluation Agreement to participate. Upon completion of the two week trial period, the trialled Fluke tool must be returned in good condition to Fluke using the self-addressed, pre-paid return label, or shipping courier details provided. Limited to one free trial per person. Offer valid until 30 June, 2015 or until supplies last.

Employees, directors and officers of Fluke Corporation in Australia ("Sponsor"), its parent companies, affiliated companies, subsidiaries, distributors, representatives, and their immediate families (parents, siblings, children and spouse) and persons living in the same household (whether related or not) are not eligible to receive the free two week trial. Employees or representatives of government entities, including government owned or controlled companies are not eligible to participate in the Promotion. Fluke may choose to screen applicants and their proposed uses of the selected Fluke trial tool for suitability.

2. PROMOTION PERIOD

The promotion starts at 8:00 AM Australian Eastern Standard Time (AEST) on 4 March 2015 and ends at 5:00pm AEST on 30 June 2015 (the "Promotion Period"). Australian Eastern Standard Time shall control for all purposes of this Promotion. Sponsor's computer shall be the official time-keeping device for the Promotion.

- b. Trial Requests: All requested contact information must be provided for your request to be valid. All participants and requests are subject to verification by the Sponsor, in its discretion. Any request that does not comply with any aspect of these Terms & Conditions may be rejected by the Sponsor. By participating in the Promotion, you consent to being placed on an email list for promotional and other purposes, subject to the Sponsor's privacy policy. You may subsequently opt-out of receiving further emails from Sponsor as set forth in its privacy policy.

The recipient agrees that any data remaining on the tool upon completion of the evaluation become property of Fluke.
